

1. Description

With the Phonak RemoteControl you can change your hearing aid programs and volume.



2. Using Phonak RemoteControl

2.1 Activating the Phonak RemoteControl Pull out the battery protective tab to activate your Phonak RemoteControl.



Use the slider to switch on or off.



2.3 Understanding the indicator light

2.4 Pairing the Phonak RemoteControl with your hearing aids

To use your Phonak RemoteControl with your hearing aids, pair them according to the following instruction.

- ① For an ideal pairing, please ensure you are in an area with as few other active Bluetooth devices as possible.
- ① It is only necessary to perform the pairing procedure once with your hearing aids. After the initial pairing, your Phonak RemoteControl will connect automatically with your hearing aids.
- 1. Switch off your hearing aids and then on again. This will set them into pairing mode for up to 3 minutes. Place them on a surface so that they are within 15 cm of the Phonak RemoteControl.
- 2. Ensure your Phonak RemoteControl is switched off.
- 3. While pressing and holding the volume up "+" button on the Phonak RemoteControl, switch it on.

- 4. When the light indicator starts to blink blue, release the volume up "+" button. This indicates the Phonak RemoteControl is now in pairing mode.
- 5. The Phonak RemoteControl and your hearing aids will now pair automatically.
- 6. After a successful pairing the light indicator turns solid green for 5 seconds. You can now use your Phonak RemoteControl.
- ① If the light indicator starts to blink blue again and you use two hearing aids: The Phonak RemoteControl is still in pairing mode and is attempting to pair with your second hearing aid. After a successful pairing the light indicator turns solid green for 5 seconds. You can now use your Phonak RemoteControl.
- ① If the light indicator starts to blink blue again and you only use one hearing aid: Press the volume down "-" button on your Phonak RemoteControl to manually exit pairing mode.
- ① If the pairing fails, look for a possible solution in Troubleshooting (chapter 5).


2.6 Changing hearing aid program




- ① Hearing aids may beep to confirm selection, depending on your hearing aid configuration.
- ① Changes are applied to both hearing aids at the same time.
- ① For information about your personal settings, ask your hearing care professional to print your Phonak RemoteControl instructions.


3. Inserting a new battery

3.1. Open the battery compartment





3.2. Remove the battery from the battery compartment



3.3. Insert the new battery



①The Phonak RemoteControl requires a lithium button cell (CR2032)

3.4. Close the battery compartment



- ① Keep batteries out of reach of children, mentally challenged people or pets.
- This device uses a Lithium button cell. These batteries are very dangerous if they are swallowed. Swallowing may lead to serious injury in as little as 2 hours or death, due to chemical burns and potential perforation of the oesophagus.
- If you suspect that a battery was swallowed, immediately consult your physician without any delay!
- After a battery exchange, make sure the battery compartment of the device is securely closed. Do not leave the depleted battery unattended and dispose it of immediately in a secure place. Flat batteries can still be dangerous.

4. Reset the Phonak RemoteControl

① A reset of your Phonak RemoteControl will remove the pairing to your hearing aids.

Press the volume up "+" button and the program change button for more than 10 seconds.

8. Important safety information

Please read the information on the following pages before using your device

8.1 Hazard warnings

Your device operate between 2.4 GHz-2.48 GHz frequency range. When flying please check if flight operator requires devices to be switched off.

⚠ Keep this device out of reach of children aged under 3 years and mentally challenged people or pets.

This remote control uses low-power, digitally coded transmission to communicate to your hearing system. Although unlikely, interference with medical devices (i.e. pacemakers, defibrillators, etc.) is possible. Therefore users must not keep this remote control in or near a breast pocket.

⚠ Changes or modifications to the device that were not explicitly approved by Sonova are not permitted. Such changes may damage your device.

⚠ If problems occur which cannot be resolved by following the remedy guidelines in the troubleshooting section of this user guide, consult your hearing care professional.

This device is not for children below 36 months. The usage of this device by children and individuals with cognitive impairment should be supervised at all times to ensure their safety. It is a small device and contains small parts. Do not leave children and individuals with cognitive impairment unsupervised with this device. If swallowed, consult a physician or hospital immediately as the device or its parts can cause choking!

⚠ Use of this equipment adjacent to or stacked with other equipment should be avoided because it could result in improper operation. If such use is necessary, this equipment and the other equipment should be observed to verify that they are operating normally.

Remove the battery if you are not using the device for a long period of time.

- ⚠ Do not use the device in explosive areas (flammable anesthetics, mines or industrial areas with a danger of explosions), oxygen rich environments or where electronic equipment is prohibited.
- ! Use of accessories, transducers and cables other than those specified or provided by the manufacturer of this equipment could result in increased electromagnetic emissions or decreased electromagnetic immunity of this equipment and result in improper operation.
- A Portable RF communications equipment (including peripherals such as antenna cables and external antennas) should be used no closer than 30 cm (12 inches) to any part of the Phonak RemoteControl including cables specified by the manufacturer. Otherwise, degradation of the performance of this equipment could result.

8.2 Information on product safety

- (i) Protect the device from excessive moisture (bathing, swimming), heat (radiator, car dashboard) or direct skin contact when sweating (workout, fitness, sport).
- Do not drop the device. Dropping onto a hard surface can damage your device.

- Special medical or dental examination including radiation described below, may adversely affect the correct functioning of your device. Remove and keep it outside the examination room/area before undergoing:
 - Medical or dental examination with X-ray (also CT scan).
 - Medical examinations with MRI/NMRI scans, generating magnetic fields.
- (i) Protect the device sockets and battery slot from dirt and debris.
- The digitally-coded, transmission technology used in the device is highly reliable and experiences virtually no interference from other devices. It should be noted, however, that when operating the hearing system near computer equipment, larger electronic installations or other strong electromagnetic fields, it may be necessary to be at least 60 cm (24") away from the interfering device to ensure proper operation.

- (i) Keep the device at least 10 cm away from any kind of magnets.
- (i) When the device is not in use, turn it off and store it safely.
- ① Do not use your device in areas where electronic equipment is prohibited.

8.3 Other important information

- (i) High-powered electronic equipment, larger electronic installations and metallic structures may impair and significantly reduce the operating range.
- (i) If the hearing aids do not respond to the device because of an unusual field disturbance, move away from the disturbing field.

9. Care and maintenance

Cleaning of the device

Use a lint-free cloth for cleaning. Dry cleaning is preferred. If necessary, the surface can be cleaned with mild soapy water. However, the cloth should be damp and not dripping wet to prevent moisture from entering the device. Do not use aggressive substances such as solvents or paint thinners as these can impair the surface.

10. Service and warranty

10.1 Local warranty

Please ask the hearing care professional, where you purchased your devices, about the terms of the local warranty.

10.2 International warranty

Sonova offers a one year limited international warranty, valid as of the date of purchase. This limited warranty covers manufacturing and material defects. The warranty is valid only if proof of purchase is shown.

The international warranty does not affect any legal rights that you might have under the local warranty or the applicable national legislation governing sale of consumer goods.

10.3 Warranty limitation
